

# Special Report: By-Laws

# By-Laws Amentments to be discussed at the June General Meeting:

Section 4: <u>Sustaining Member</u> A Sustaining member may be any Senior member who has been a Senior member of the Club for a period of 15 years and has attained the age of 65 years. The class of Sustaining member may be awarded by the Board of Directors upon written request of the Senior member. The Sustaining member shall pay 50% of the annual dues and assessments and shall have all the rights and privileges of a Senior member. (On \_\_\_\_\_\_, 2009, this Section 4 was amended to increase the number of years from 10 to 15 years. Sustaining Members on such date shall continue to be Sustaining Members notwithstanding such Member has less than 15 years membership; provided all other requirements of membership continue to be satisfied.)

#### Article X

Section 2: <u>Nominees.</u> Nominees for officers and directors shall be chosen from the ranks of Senior, Life and Sustaining members or their respective spouses. Such members shall be in good standing and have been a member for a minimum of one year before taking office. Candidates may be nominated and elected prior to satisfying the one year membership requirement.

#### Article III

Section 109: Domestic Partner A Domestic Partner is defined as a person living in a cohabitative relationship with a member. A member's Domestic Partner shall be identified upon initial nomination for membership or by subsequent identification (including changes) by formal written notification from the member to the Board of Directors accompanied by a "Statement of Financial Responsibility for a Domestic Partner". The privileges and duties outlined below extend to the Domestic Partner of any member. The member assumes responsibilities for any expenses or liabilities incurred at the Club by that member's Domestic Partner. This responsibility continues as long as any expenses or liabilities are incurred by that Domestic Partner.

- (a) The initiation fees and dues paid by a member shall entitle the member's Domestic Partner to the use of the Club facilities, as outlined by these bylaws and the Clubhouse Rules. A key card to the clubhouse and a membership card shall be issued to the Domestic Partner.
- (b) The Domestic Partner may not vote nor hold an elected office.
  (c) Upon termination of the member's association with the Club or the Partner, the Partner's affiliation with the Club shall cease, the membership card, the key card and any other keys to the Club shall be surrendered to the Club's Membership Chairperson.

Section 910: Member's Spouse or Domestic Partner The privileges and duties outlined below extend to the spouse of all members. A member's spouse shall be identified upon initial membership nomination or by subsequent identification (including changes) by formal written notification from the member to the Board of Directors. - (a) The initiation fees and dues paid by a member shall entitle the member's spouse or Domestic Partner to the use of the Club facilities, as outlined in these Bylaws and the Clubhouse position in the Club that the member is eligible to hold. A member and the member's spouse or Domestic Partner may not hold any elected positions concurrently.
- (d) A spouse or Domestic Partner who has been affiliated with the Club for 15 years and has attained the age of 65 years is eligible to be considered for Life membership.
- (e) Upon termination of the member's association with the Club, divorce or termination of the Domestic Partnership, the Spouse or Domestic Partner's affiliation with the Club shall cease, the membership card, the key card and any other keys to the Club shall be surrendered to the Club's Membership Chairperson. Section 12: Transfer of Membership Memberships can be transferred as follows:
- (a) In the event of the death of a Senior member, Life member or Sustaining member, the spouse shall, if desired, become a Senior member of the same classification upon written request to the Board of Directors.
- (c) If a resigning member's spouse holds an elected office, and a transfer of membership has not been affected, then the spouse must officially join Sequoia Yacht Club by paying full initiation fees and dues, or resign from the position and terminate all affiliation with the Club.
- (c) A membership may only be transferred to that member's spouse or domestic partner. A member may transfer their membership to their spouse or domestic partner, provided the spouse or domestic partner meets the requirements of that membership. Such transfer shall be in writing, and subject to the approval of the Board of Directors.

Rounding Alcatraz, the wind picked up to 10-15kts through the slot until we hit the city front with light and variable winds again. Passing through the Bay Bridge, the big choice was to head down the east side or the west side of the bay. The boats that headed down the west side had the wind pick up first. From SFO to the San Mateo Bridge we had 15-22 kts of wind. In the Spinnaker division, Patrick Kohlman, Joyicity took first place followed by Charlie Watt, Head Rush with 2<sup>nd</sup> place. In the Non-Spinnaker division, Chip Conlon's Fancy took first place with Rick Dalton, Iowa taking 2nd place. A special thanks to Ron Brown, Westpoint Regatta Race Director; Mark Saunders owner of Westpoint Harbor; and Sherry Smith.

Summer Series Race #2 was held on Saturday, May-16. It was another beautiful day of south bay sailing with temperatures in the 80's. With my wind crystal ball predicting light winds, we picked a short course of 4.83nm (S/f- Sp-12p- Ys- s/F). We were able to start the race at 12:30pm with 5 kts of wind. A total of 8 yachts started the race; 5 in the Spinnaker Division and 3 in the Non-Spinnaker Division.

In the Spinnaker Division, John Ryan's Pizote took first place honors. Paul McCarthy, Lucky Duck took second place and Ray Collier, Linda carol was in third. ### Sequoia Reads for June

What can floating debris teach us about the world's oceans? Find out from a new book by oceanographers Curtis Ebbesmeyer and Eric Scigliano, *Flotsametrics and the Floating World.* Please join us on **June 1 at 19:00** to discuss this entertaining autobiography by this resourceful oceanographer who figured out how to use flotsam—floating trash—to uncover the movements of the world's oceans.

In the early 1990's Ebbesmeyer, on a tip from his mother, started recording the locations where hundreds of Nike shoes were washing up along the West Coast. The shoes had been spilled from a container on a ship hit by a severe Pacific storm a year earlier. From that first, opportunistic attempt at turning beachcombing into a science by retracing the shoes 2,000 mile trip, Ebbesmeyer has gone on to understand and describe the detailed movements and order of the worlds oceans.


