

A Look to the Past

This month Fleming Blucher, Commodore '60, gave me some news articles from the Redwood City Tribune that he had saved. Bob Hoffman has been collecting information regarding the Club for a great many years and he passed along a storage box full of stuff. I'm gong to look through the items and pass bits and pieces onto you the in the coming months. I hope you find it interesting for it is part of our Club's heritage and tradition.

In the old picture of the marina (there is one in our office), there is a two-story structure that was built by the city for the Redwood City Yacht club. It cost \$2,849 and the club would rent it for \$25 per month. They would hire a watchman. Besides building the marina, the city planned to have a salt-water swimming pool on the municipal acres. The Depression years of '31 and '32 dealt the first blow the Redwood City's grand plan for their yacht harbor. The hard times cause the yacht club to consolidate with the Sportsmen's Association and for a while kept their activities alive. When the yacht club finally became inactive and disbanded, the city used the building for their harbormaster. When Sequoia YC organized in 1939, they were permitted to rent the upper story until they built our clubhouse.

We have been interested in the organizers of the Redwood City YC, which was established in the late 1920's. A news article in the RWC Tribune states that the members included: George Kneese, County Engineer; Councilman Hildebrant; Terry Cumberson of Redwood City; William Downy of Atherton; and William Hanscom of San Carlos. All were boat owners and sailing loves.

Did you know that the water in front of the club house was called Boundary Slough and once connected with Westpoint Slough?

Thank you, Fleming and Bob, for all the valuable information you saved and have passed on to us.

The August edition of Latitude 38 had a great article about a special "couples" Crew Over Board (COB) program designed and taught by Captain Mary SwiftSwan of Afterguard Sailing Academy in Alameda. We've nabbed some of her precious time to come train us. More details below.

Crew Over Board (COB) Training Redwood City Marina, September 19th and 20th

Captain SwiftSwan has agreed to conduct a special session in the South Bay in our own Redwood City Marina on September 19 and 20. For \$50 per person (proceeds go to the Afterguard Youth Sailing Program), there will be a 90 minute "chalk talk" on Friday, 9/19 after the D-i-D, covering safety equipment, methods and hoisting techniques for a variety of boat designs and sea conditions.

Saturday, 9/20, participants on all boats will have an 8:30 start for 1.5 hours of practice in the turning basin. By 11:00 the group will move to more open waters to work with real divers as "victims" to conduct actual rescues. Each participant will have a turn and will be observed against a checklist. After the on-the-water time, the large group will reconvene with the divers for a debriefing session at the clubhouse.

Enrollment is limited to 20-25 participants.


Aquatic Park Cruise Out October 11-12




